17.1.1 To appoint the Chairman of the parish council for the year 2017/18

Mr D Barker was nominated by Cllr. Christian and seconded by Cllr. Gladders with unanimous agreement by the council and duly elected to serve as Chairman for the year 2017/18.

17.1.2 To appoint the Vice Chairman of the parish council for the year 2017/2018

Mr S Caley was nominated by the Chairman and seconded by Cllr. Gladders with unanimous agreement by the council and duly elected to serve as Vice Chairman for the year 2017/18.
